## Details

The **TCS London Marathon** has become one of the most desirable races in the world. Known for its flat course, this gem of a marathon will be memorable when you cross the finish line in front of Buckingham Palace. Get your guaranteed entry with "I Run the Globe" to participate in the largest race in Europe.



The London Marathon is one of the **Abbott World Marathon Majors**, along with Boston, New York, Tokyo, Chicago, and Berlin, making it a mandatory race to complete your 6-star medal quest.

Moreover, this course will take you through many of the city's historic landmarks. During your 42.195 km journey, you will run across Tower Bridge, through the 'City of London' (financial district), past Big Ben, and finish at the iconic Buckingham Palace.



London's numerous attractions have made it one of the world's most popular tourist destinations, drawing approximately 28 million visitors annually.

It is easy to use **public transportation** in London. The Tube, as the Brits call it, is simple to navigate, while the red double-decker buses offer the opportunity to see the city at ground level.

Please read these General Conditions of Entry before applying to enter the TCS London Marathon – they contain important information about your safety and wellbeing. In these conditions the following definitions shall apply:

'Agreement' – the agreement between you and London Marathon Events Limited comprised of the Event Conditions and these Conditions of Entry; 'DPA' – the Data Protection Act 1998; 'Event' – the London Marathon organised by The London Marathon Events Limited; 'Event Conditions' – the terms and conditions, in addition to these Conditions of Entry, provided to you by London Marathon Events Limited in respect of the Event from time to time; 'Event Date' – the announced date of the Event; 'Event Details' – the name, image, and event time of each participant 'Fee' – the fee payable by you (or the charity from whom you obtained the entry) to London Marathon Events Limited in consideration of your participation in the Event; 'Force Majeure Event' – means any circumstance not within a party's reasonable control including: acts of God, flood, drought, earthquake or other natural disaster; epidemic or pandemic; terrorist attack, civil war, civil commotion or riots, war, threat of or preparation for war, armed conflict, imposition of sanctions, embargo, or breaking off of diplomatic relations; nuclear, chemical or biological contamination or sonic boom; any law or any action taken by a government or public authority, including imposing an export or import restriction, quota or prohibition; collapse of buildings, fire, explosion or accident; solely where LMEL is seeking to rely on clause 5, non-performance by suppliers or subcontractors to LMEL or a death of a member of the Royal family; athlete boycott; and interruption or failure of utility service but excluding any labour or trade dispute, strikes, industrial action or lockouts. 'LMEL' – means London Marathon Events Limited incorporated and registered in England and Wales with number 01528489 whose registered office is at 190 Great Dover Street, London SE1 4YB; 'Officials' – any event officials as appointed by London Marathon Events Limited from time to time; 'Partners' – any sponsor, suppliers, licensees or partners of the event from time to time; 'Personal Data' – shall have the meaning given to it in the DPA; 'Privacy Policy' – London Marathon Events Limited's privacy policy which can be found here; 'Rules' – the laws, rules, and regulations of British Athletics and any other relevant governing body; 'you' 'your' – the entrant to the Event or, where you are signing as a parent or guardian for a child aged under 18 for whom you are responsible, your child;

### **ENTRY**

By submitting your application you are agreeing to enter into the Event, pay the Fee to LMEL, participate in the Event on the Event Date, abide by the Rules and also to abide by these Conditions of Entry, the Event Conditions and any instructions given to you by the LMEL and/or officials of the Event.

Where you are provided with an electronic chip by LMEL to record your time, this should be used in accordance with the instructions. You agree to return the electronic chip at designated points located near to the finish line of the Event or within 30 days by post to London Marathon Events Limited, 190 Great Dover Street, London SE1 4YB. If you fail to return the electronic chip, LMEL will be entitled to charge you for the replacement cost of the chip.

Participants in the Event are subject to the British Athletics competition rules and the rules of World Athletics and British Athletics. If you are an entrant using a wheelchair you will also be subject to the rules of the World Para Athletics. If there is any conflict between these Rules and the Agreement, the Agreement shall apply to the extent of the conflict.

### **EVENT SAFETY**

At all times during the Event you must adhere to all instructions given by LMEL and Event officials from time to time. Participation in the Event is personal to you; you are strictly prohibited from swapping, selling or transferring or offering to sell, swap or transfer the place in the Event or allowing any other person to wear the Event number.

Any breach of this Condition shall render the entry void. If you are found to be in breach of this Condition, LMEL reserve the right to exclude you from participation in future Events. You are not permitted to use the following items in the Event:- any wheeled device (subject to Condition 2.5);

any artificial aid; any pets or animals; or any other item that could potentially inhibit the flow or safety of other participants or which LMEL, in its reasonable opinion, deems may cause danger or risk of danger to you or other participants.

You warrant to LMEL that you will be on the Event Date, sufficiently fit and healthy to participate in the Event unaided and in accordance with the Agreement. If you are in any doubt LMEL recommends that you seek medical advice.

If you are entered into the wheelchair section of the event, you are only permitted to use a self-propelled wheelchair without gears or any mechanical, powered or electronic aid or device. If in the elite wheelchair section of the Event you will only use a racing wheelchair approved by LMEL.

### **EVENT EJECTION**

LMEL reserves the right to refuse entry to the Event or to ask you to cease participation if:- you fail to follow instructions given by Event officials; you attempt to participate in the Event in a manner that LMEL, acting reasonably, believes:- may cause injury to you or another participant; may damage or harm the environment;

in our opinion is likely to cause offence; or otherwise causes a risk or potential risk to health and safety including any failure, in whole or in part, to comply with the restrictions in Condition 2; in LMEL's opinion you are unfit to participate in the Event due to:- the consumption or use of alcohol or drugs; an injury or illness; you fail to arrive at the start location at the specified time; or you are unable to make sufficient progress in the Event to allow you to complete the Event in line with timelines set by Event officials. Competitors will only be eligible for a medal and to feature in the results in they complete the course before



the official cut off time which is currently 18:30 on the day of the Event (subject to variation at LMEL's discretion).

If, in accordance with Condition 3.1, you are refused entry to the Event or LMEL asks you to cease participation in the Event, you must remove your runner's identification number and electronic chip and return them to an Event official.

Participants will have their results annulled and be banned from all future events organised by LMEL for a period of up to five years if:

- their running number is used by someone else in the event, participating in the event using a number registered to another participant, or using a counterfeit number.
- they are found to be selling their number to another person.
- they gain, or seek to gain, a GFA (Good for Age) or Championship place using another participant's time;
- they falsify information on the entry form.
- they enter the ballot more than once using different email addresses; and
- they commit any other breach of these Conditions of Entry and/or the Event Conditions.

A second breach of any nature will mean results being annulled and a ban of up to life from all future LMEL events to be determined in LMEL's sole discretion. Any decision made by LMEL in relation to Conditions 3.3 and/or 3.4 shall be final.

### **CANCELLATION BY YOU**

You should inform us immediately in the manner LMEL sets out as being required if you need to withdraw for any reason. If you do so, your fee will not be refunded but, if this is not an entry that you have already held over, you will be permitted to have a guaranteed entry for the next year's Event by applying in the required manner. In the case a Good For Age or Championships entry you must have achieved the required qualifying time within the relevant period. If you have obtained a place from a charity then the place will revert to the charity.

### **CANCELLATION BY US**

LMEL is under no obligation to hold the Event and may cancel the Event for any reason.

LMEL may also cancel your entry if you have obtained it through a third party (such as a club, sponsor or charity) and:

the third party is no longer entitled to that entry; or  
the third party informs us that they no longer wish for you to have the entry.

In such circumstances:- LMEL will, if practicable, provide written notice of cancellation to the address LMEL holds for you. In the event that written notice is not practicable due to the timescales involved LMEL will use reasonable endeavours to provide other suitable methods of notice including, e-mail, mobile phone, text message, television and radio broadcasts; and you will receive a refund of the Fee unless you choose another option that LMEL provides (which may include, but is not limited to, deferment). For the avoidance of doubt, LMEL is under no obligation to offer alternative options should it cancel the Event.

In the event of cancellation of the Event for any reason, LMEL will not be liable for (excluding the Fee) any costs

incurred as a result of cancellation including, but not limited to, any travel or accommodation costs.

In the event of cancellation of the Event for any reason, and should LMEL opt to provide you with a refund, LMEL shall only be obliged to refund the Fee to you. For the avoidance of doubt, should the course distance be reduced in accordance with Condition 7.1, you agree that the Event is still deemed to be staged and that LMEL will not be liable to you for any refund.

### **USE OF IMAGE**

The Event may be televised, filmed and/or otherwise recorded and photographs may be taken all of which may capture your participation in the Event. You agree to the publication of such photographs, filming, recording and broadcasts and their use by us and those authorised by us in any way which LMEL may see fit now or in the future including but not limited to film, broadcast, radio, TV, publications and publicity.

### **LIABILITY**

In no event shall LMEL be liable to you whether for breach of contract, any tortious act or omission (including negligence) or otherwise, under or in connection with the Agreement for any:
